- This certificate does not constitute an authorization to operate the types of aircraft referred to in condition 5. No 1. The authorization to operate the aircraft is the AOC.
- Termination, suspension or revocation of the AOC of a air carrier licensed in accordance with Regulation (EC) No 1008/2008 automatically invalidates the present certificate in relation to the aircraft registrations specified in the AOC, unless otherwise explicitly stated by the competent authority.
- Subject to compliance with the previous conditions, the certificate shall remain valid for an unlimited 7. duration unless the certificate has previously been surrendered, superseded, suspended or revoked.


