- 4. Where the continuing airworthiness management organisation subcontracts under its management system the service of an (several) organization(s), this certificate remains valid subject to such organization(s) fulfilling the applicable contractual obligations.
- 5. This certificate does not constitute an authorization to operate the types of aircraft referred to in condition No 1. The authorization to operate the aircraft is the AOC.
- 6. Termination, suspension, or revocation of the AOC of an air carrier licensed in accordance with Regulation (EC) No 1008/2008 automatically invalidates the present certificate in relation to the aircraft registrations specified in the AOC except when the CAMO is contracted in accordance with point M.A.201(ea) of Annex I (Part M) to Commission Regulation (EU) No 1321/2014, unless otherwise explicitly stated by the competent authority.
- 7. Subject to compliance with the previous conditions, the certificate shall remain valid for an unlimited duration unless the certificate has previously been surrendered, superseded, suspended or revoked.
