### Avviż 02/2024 – Kriterji għat-Trasferimenti ta' Permessi ta' Irmigġjar

L-Awtorità tixtieq t-informa u tfakkar lill-pubbliku li, skont ir-Regolamenti tal-Irmigġjar ta' Bastimenti Żgħar u Dgħajjes (S.L.499.11), l-irbit u l-irmigġ fuq il-mollijiet immaniġġjati mill-Awtorità kif ukoll l-irbit u l-bagi fil-baħar huma proprjetà tal-Awtorità.

Il-permess ta' irbit/irmigġ huwa personali għad-Detentur tal-Permess bħala sid id-dgħajsa, u mhux trasferibbli, lanqas (imma mhux biss) f'każ ta' bejgħ jew trasferiment tad-dgħajsa ħlief għall-Kriterji għat-Trasferiment ta' Permessi ta' Irmigġjar imsemmija hawn taħt. Jekk id-dgħajsa tiġi trasferita jew mibjugħha, il-Permess Temporanju ta' Irbit jiġi awtomatikament revokat mingħajr il-ħtieġa ta' avviż ulterjuri, u l-Awtorità għandha tieħu lura l-pussess tal-Irbit/Irmigġġ immedjatamente, sakemm id-Detentur tal-Permess ma jissostitwixx id-dgħajsa fejn din tkun ta' l-istess daqs jew daqs xieraq għall-irbit/irmigġ, kif l-Awtorità fid-diskrezzjoni unika tagħha tista' tiddeċiedi.

#### Kriterji għat-Trasferiment ta' Permessi ta' Irmigġjar

It-trasferiment ta' permess ta' irbit/irmigġ jeħtieġ l-approvazzjoni bil-miktub tal-Awtorità. Trasferiment jista' jiġi awtorizzat biss f'dawn il-każijiet:

1. Meta dgħajsa tiġi akkwistata permezz ta':
  - a) Wirt; jew
  - b) Donazzjoni bejn axxidenti u dixxidenti u dik id-dgħajsa għandha permess temporanju validu ta' irbit.
2. Fil-każ ta' trasferiment ta' dgħajsa MFA jew MFB b'permess temporanju ta' irbit validu, għal dak l-irbit/irmigġ partikolari.

F'kull wieħed mill-każijiet imsemmija hawn fuq, l-applikazzjoni relativa flimkien mad-dokumenti meħtieġa għandhom jiġu sottomessi u approvati mill-Awtorità u huma suġġetti għal čerti termini li l-Awtorità tista' timponi minn żmien għal żmien.

Barra minn hekk, jekk id-dgħajsa ma taqax taħt wieħed mill-kriterji msemmija hawn fuq, wieħed jista' jissottommetti applikazzjoni għal Permess Temporanju ta' Irbit, billi jindika l-lokalitajiet preferuti għal dak l-irbit/irmigġ. L-applikazzjoni mbagħad tiġi elenkata fil-lista ta' stennja relevanti skont il-każ.

### Notice 02/2024 – Criteria for Transfers of Mooring/Berthing Permits

The Authority would like to inform and remind the public that, in terms of the Mooring and Small Ships and Boats Regulations (S.L.499.11), moorings and berths on quays managed by the Authority as well as mooring and buoys at sea are the property of the Authority.

The mooring/berthing permit is personal to the Permit Holder of the vessel, and non-transferable, not even (but not solely) in case of sale or transfer of the vessel except for Criteria for Transfer of Mooring/Berthing Permits mentioned below. Should the vessel be transferred or sold, the Temporary Mooring Permit shall be automatically revoked without the need of any further notice and the Authority shall resume possession of the Mooring/Berth unless the Permit Holder replaces vessel where such is of the same size or size is appropriate for the mooring/berth, as the Authority in its sole discretion may so determine.

#### Criteria for Transfer of Mooring/Berthing Permits


The transfer of a mooring/berthing permit will require the written approval of the Authority. A transfer may only be authorized in the following cases:

1. When a boat is acquired by:
  - b) Inheritance; or
  - c) Donation between ascendants and descendants and such boat has a valid temporary mooring permit.
2. In the case of transfer of an MFA or MFB vessel with a valid temporary mooring permit, for that particular mooring/berth.

In any of the above-mentioned cases, the relative application together with the required supported documents must be submitted and approved by the Authority and is subject to certain terms which the Authority shall impose from time to time.

Furthermore, if the vessel does not fall under any of the above criteria, one may submit an application for a Temporary Mooring Permit indicating the localities preferred for such mooring/berth. Application shall then be listed in the relevant waiting list accordingly.
