## Data Protection Privacy Notice

Transport Malta of Triq Pantar, Lija, Malta LJA2021 is the Data Controller for the purpose of the Data Protection Act CAP. 440 and General Data Protection Regulation (EU) (GDPR) 2016/679. ### 1. The information we collect and how we use it

- 1.2. ### 2. To whom we disclose information

### 3. Data Subject Rights

- 3.1. With respect to your privacy rights, Transport Malta is obliged to provide you with reasonable access to the Personal Data that you have provided to us. Your other principal rights under data protection law are:

  - 3.2. We will acknowledge your request within seventy-two (72) hours and will do our utmost to handle it promptly.
