Valletta Pageant of the Seas – August 2020

The Ports and Yachting Directorate, Transport Malta, notifies mariners that the "Valletta Pageant of the Seas" event will be held in the Grand Harbour on Sunday 16th August 2020, with rehearsals being held between Wednesday 12th August 2020 and Saturday 15th August 2020.

At the start of each rehearsal and the main event four (4) lit buoys 1, 2, 3 and 4 will be laid in the following positions (as shown on attached charts 1 and 2). They will thereafter be removed at the end of each day.

The Valletta Pageant of the Seas rehearsals will be held as follows:

Wednesday 12 th August 2020 between 1900 hours and 2359 hours,	
Thursday 13 th August 2020 between 1800 hours and 2000 hours	and
between 2100 hours and 2359 hours,	
Friday 14 th August 2020 between 1900 hours and 2359 hours,	
Saturday 15 th August 2020 between 2100 hours and 2359 hours.	

During the above-mentioned dates and times, movement in the Grand Harbour will be restricted within the area enclosed by the imaginary lines A - B, C - D, E - F, F - G and the intermediate coastline as shown on attached chart 1.

Merchant traffic will retain priority over the vessels participating during the rehearsals. Valletta VTS will coordinate accordingly.

Barriera Wharf and Lascaris Wharf are to be clear of all vessels from Sunday 16th August 2020 at 0800 hours to Monday 17th August at 0800 hours.

The main event will be held on Sunday 16th August 2020 between 1615 hours and 2300 hours.

During the main event the Grand Harbour will be closed to all within the area enclosed by the imagery lines J - K, L - M, N - O, P - Q, R - S, T - U, V - W and the intermediate coastline as shown on attached chart 2.

The port closure and prohibited area will be effective as of Sunday 16th August 2020 from 1400 hours to 2315 hours local Time.

The approaches to the fairway between the breakwaters, is to be kept clear during these hours.


During the event, unauthorized vessels will not be allowed within the restricted area.


