**Port Reception Facilities for the Delivery of Waste from Ships:
Advance Waste Notification and Waste Delivery Receipt**

The Authority hereby reminds all concerned parties that Directive (EU) 2019/883 on port reception facilities for the delivery of waste¹ from ships² is applicable as from 28th June 2021. The requirements of this Directive have been transposed through the Port Reception Facilities for the Delivery of Waste from Ships Regulations (S.L. 499.71)³, also coming into force on the same date.

Owners, Masters and Agents of a ship, falling within the scope of the Vessel Traffic Monitoring and Reporting Requirements Regulations (S.L. 499.34), bound for a port or terminal in Malta, shall submit to the Authority the Advance Waste Notification as per Form in Annex '1'. Owners, Masters and Agents must also communicate such information to the port or terminal operator at which the ship will be calling, request for the authorised waste reception facility and pay the applicable fees.

Upon delivery, the operator of the authorised port reception facility or of the port or terminal⁴ where the waste was delivered, or the authorised waste carrier, shall issue and provide, without undue delay, a Waste Delivery Receipt to the Master of the ship as per Form in Annex '2'.

The Advanced Waste Notification and the Waste Delivery Receipt shall be completed truthfully and accurately in full and shall be submitted electronically through the National Single Window system tmSW before the ship arrives in or departs from Malta and within the notification timeframes established in the Regulations; and shall be kept on board and be made available upon request to the Authority.

Owners, Masters and Agents are hereby reminded that ships covered by an Exemption Certificate are exempted from the submission of the information as per attached Advance Waste Notification Form.

¹ "Waste from ships" means all waste, including cargo residues, which is generated during the service of a ship or during loading, unloading and cleaning operations and which falls within the scope of Annexes I, II, IV, V and VI to the MARPOL Convention, as well as passively fished waste.



⁴ "Terminal" means a place where ships are moored, berthed or docked to obtain services such as handling of cargo or passengers, repairs, waste removal, bunkering, laid-up and other services related to ships and maritime activities, including marinas.

The Authority wishes to remind all concerned parties regarding their responsibility to observe and comply in full with the legislation and directions given by the relevant competent authority from time to time. Without prejudice to any legal and enforcement action in terms of the Laws of Malta in respect of any breach or non-compliance, a ship may be inspected, directed to deliver the waste on board and detained until there is compliance.

The updated fees and procedures will be as established from time to time by the Authority through other Port Notices.

This Port Notice shall be applicable and must be complied with as from 9th December 2021. Port Notice 07/2016 shall remain in force and applicable until 8th December 2021.
