### Swimming event from Għar Lapsi to round Filfla and back to Għar Lapsi

The Ports and Yachting Directorate, Transport Malta, would like to notify mariners that a swimming event will be organised on Saturday 10<sup>th</sup> September 2022.

The first group of participants will swim from Għar Lapsi to round Filfla and back to Għar Lapsi, they will depart from Għar Lapsi point A, as shown on the attached chart 1, at 0530 hours. The participants are then expected to arrive back at Għar Lapsi, at approximately 1030 hours.

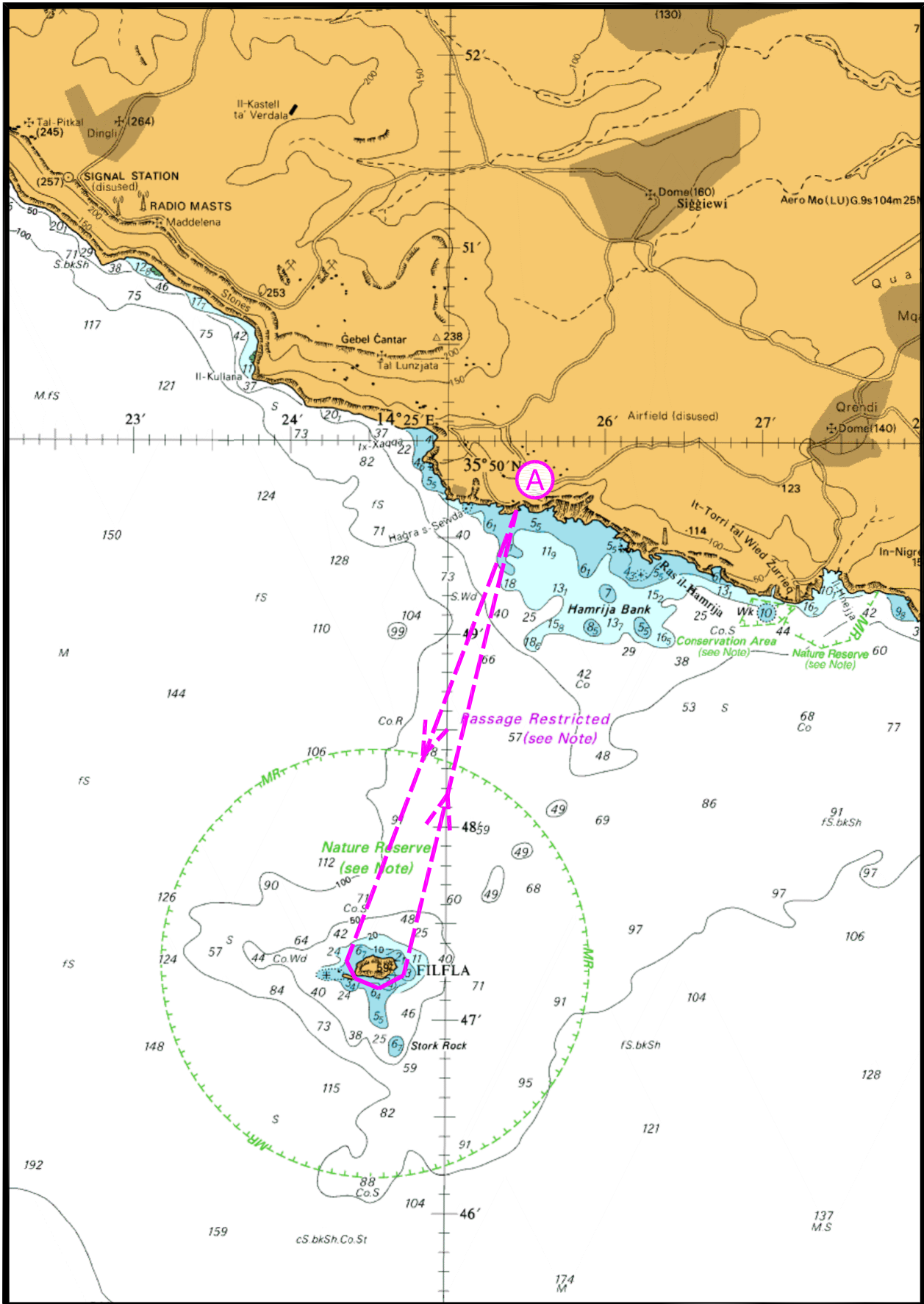
There will be another group of participants that will swim from Filfla to Għar Lapsi, they will depart from Filfla point B, as shown on the attached chart 2, at 0730 hours and are expected to arrive at Għar Lapsi point A, at approximately 1030 hours.

The participating swimmers will be accompanied by kayaks and rhibs which can afford medical support. There will be an ambulance on standby at the finishing point at Għar Lapsi.

Mariners are advised to keep a sharp lookout and navigate with extreme caution and at slow speed (no wake) when in the vicinity, on the stipulated date and time. They are to cooperate with the organisers.

All mariners are to comply with any instructions given on VHF Channel 12 and/or 16, by Valletta VTS and by any enforcement officials on site.

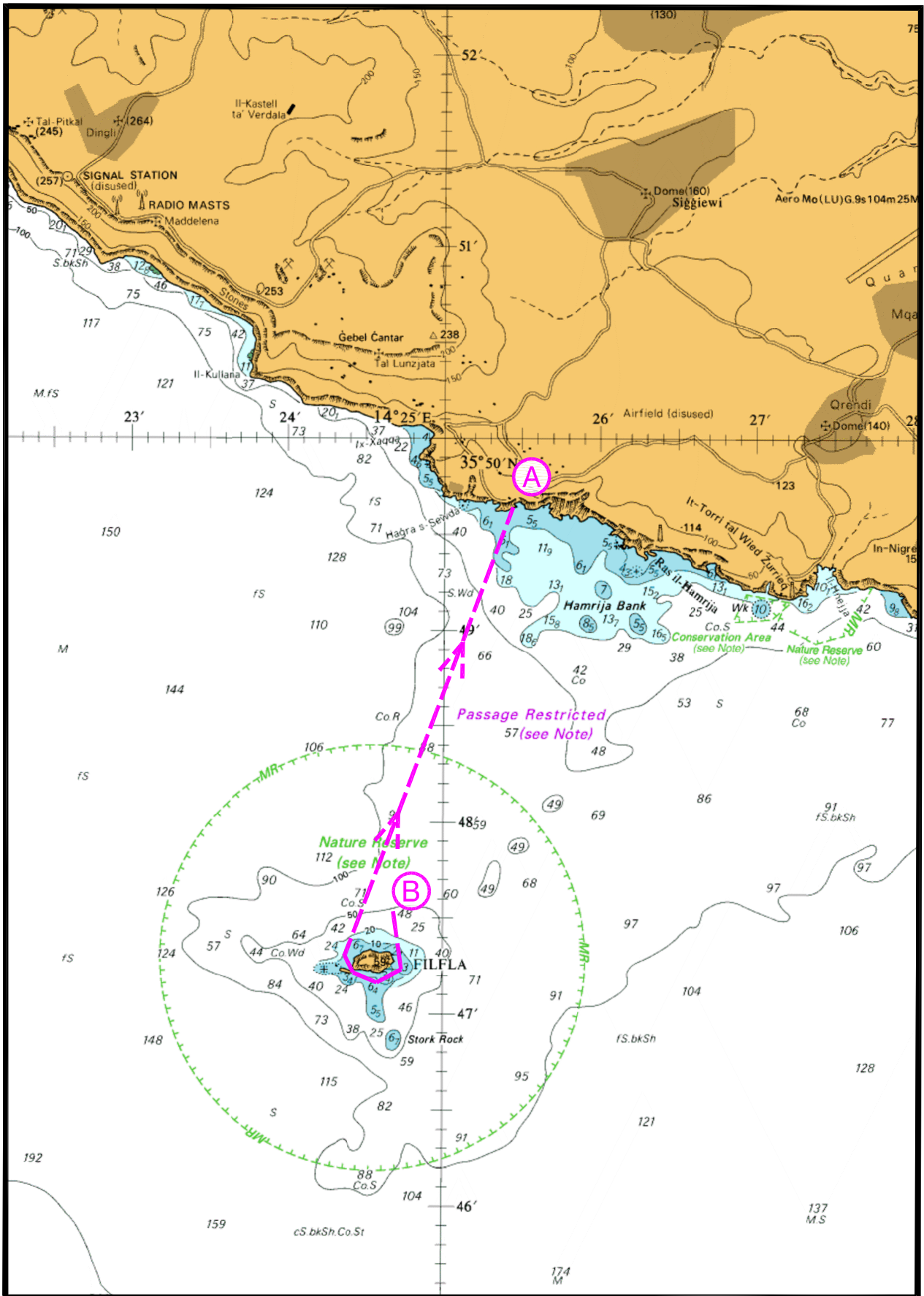
