Under 18 Regatta races in Rinella Bay - 2024

The Ports and Yachting Directorate, Transport Malta, notifies Mariners that Under 18 regatta races will be held in Rinella Bay, Kalkara, the Grand Harbour.

The regatta races will be held on Saturday 13th July 2024 from 1300 hours to 1800 hours.

Four (4) buoys will be laid in positions A, B, C and D, as indicated on attached chart, to delineate the race area.

The buoys will be laid on Saturday 13th July 2024 from 1200 hours. No vessel will be allowed to enter the designated area unless by special permission issued by Transport Malta. The buoys will be removed at the end of the races.

The positions of the buoys will be as follows:

	LATITUDE (N)	LONGITUDE (E)
A	35° 53'.845	14° 31'.355
B	35° 53'.656	14° 31'.614
C	35° 53'.612	14° 31'.565
D	35° 53'.800	14° 31'.306

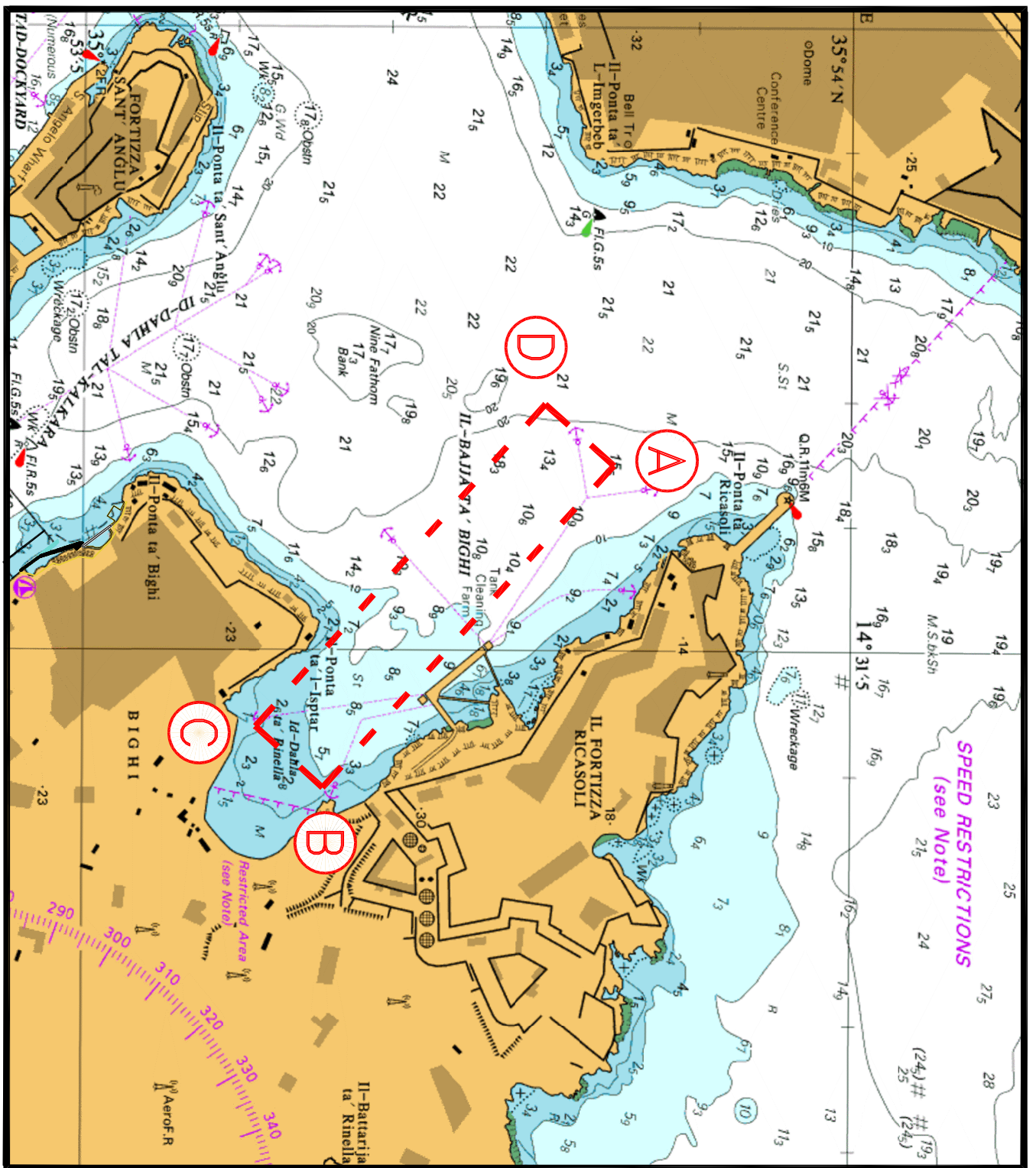
There will also be training sessions, within the same area, between Monday 1st July 2024 and Friday 12th July 2024, between 1600 hours and sunset daily. During the training sessions no buoys will be laid.

Any vessel which is within the designated area, which includes all Rinella Bay, must be removed daily from Monday 1st July 2024 to Friday 12th July 2024 between 1600 hours and sunset. They are also to be removed on Saturday 13th July 2024 between 1200 hours and 1800 hours. No vessel will be allowed to enter the area on the above-mentioned dates and times.



All mariners are to comply with any instructions given on VHF Channel 12 and/or 16, by Valletta VTS and by any Enforcement Personnel on site.
