Fireworks Display - Feast of St. Dominic - Valletta - 2024

The Ports and Yachting Directorate, Transport Malta, notifies mariners that aerial firework will be let off from St. Elmo Point – between St. Gregory Bastions (point A) and Abercrombie Bastions (point B) as shown on the attached chart, on the date and times as follows:

On Sunday 28 th July 2024	from 0800 hours till 0815 hours and from 1130 hours till 1145 hours.
On Friday 2 nd August 2024	from 0800 hours till 0815 hours, from 1200 hours till 1215 hours and from 2000 hours till 2045 hours.
On Saturday 3 rd August 2024	from 0930 hours till 0945 hours, from 1200 hours till 1215 hours and from 1830 hours till 1915 hours.
On Sunday 4 th August 2024	from 0800 hours till 0815 hours, from 1145 hours till 1200 hours, from 1930 hours till 2015 hours and from 2130 hours till 2215 hours.

Vessels moored within 200 metres from points A and B are to be removed and the areas kept clear during the displays.

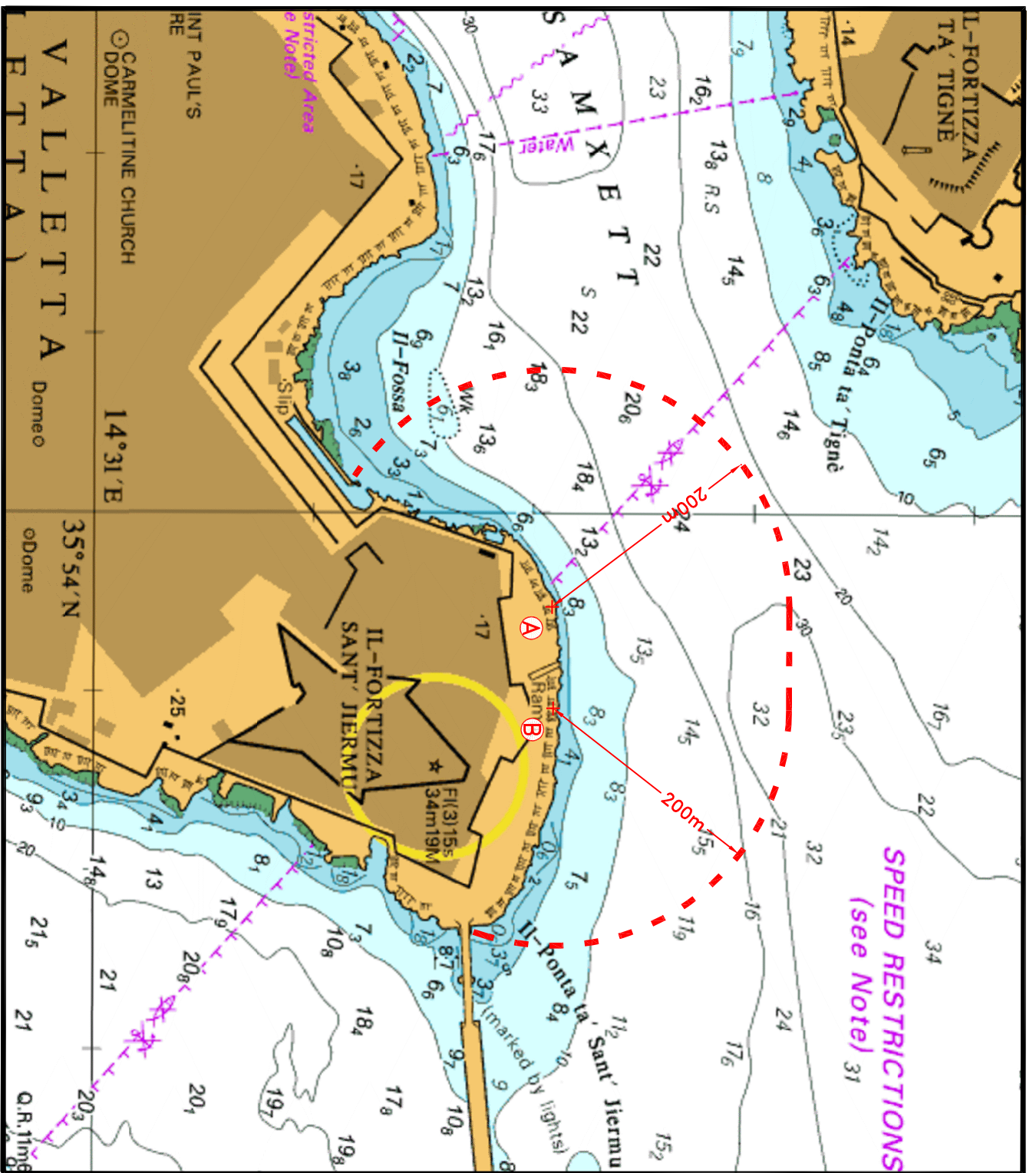
Transport Malta will accept no liability whatsoever for any damage caused by the firework displays to any vessel and her ancillary equipment, whether such vessel and her ancillary equipment are left within the 200m safety zone, or outside such safety zone, from the point from which the fireworks are let off.

Mariners are to navigate with caution and at slow speed when in the vicinity. They are to cooperate with the organisers. Instructions and directions given on VHF channel 12 and/or 16 by Valletta VTS and any enforcement personnel are to be complied with.
