Filming in different locations – Power Couple/ Last Breath

The Ports and Yachting Directorate, Transport Malta notifies all mariners, owners of vessels and divers, that filming activities will take place in Bamberin Bay – Qala and in Mgarr Port.

Filming will take place on between Monday the 14th and Saturday the 19th of October 2024, at the locations and times as follow:

Bamberin Bay - Qala

Filming is scheduled to be carried out on the 14th and the 15th of October 2024 between 0600 hours and 2200 hours, as shown on the attached chart 1.

The filming will be carried out by divers who may be accompanied by a support vessel which will be exhibiting the International Code of signals flag “A”.

During dates and timing mentioned, the filming area shown in red is to be kept clear at all times from all vessels.

All mariners, owners of vessels and divers are advised that entry into the area (as shown on the attached chart) is prohibited on the above-mentioned dates and time.

Mariners are advised to navigate with caution at slow speed and give a wide berth when in the vicinity, they are to keep out of the above-mentioned area and to comply with instructions and directions issued on VHF channel 12 and/or 16 by Valletta VTS and by any Enforcement Personnel on site.

Mgarr (Gozo)

Filming is scheduled to be carried out on the 18th and 19th October 2024 between 0700 hours and 2200 hours, as shown on the attached chart 2.



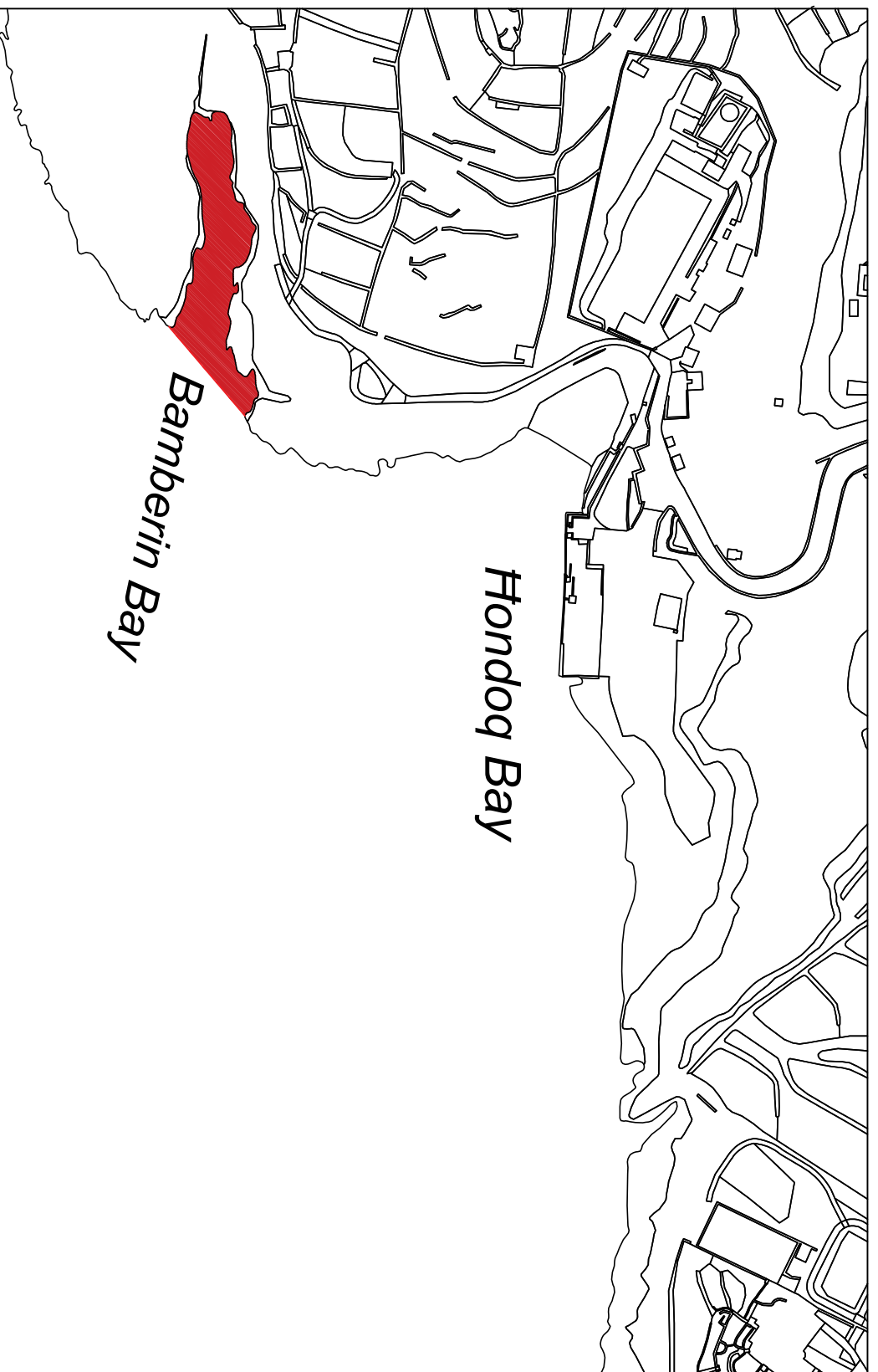

Usage of the slipway and the quay (in the area shown on the attached chart) will be restricted during the mentioned dates and times.

Mariners navigating in the vicinity of the indicated areas on the mentioned dates and time are to keep watch on VHF Channel 10 / 12 and are to cooperate with the filming crew and/or any enforcement officers in the areas.

Any instructions issued on VHF channel 10 - Mgarr Port / 12 - 16 Valletta VTS are to be complied with.

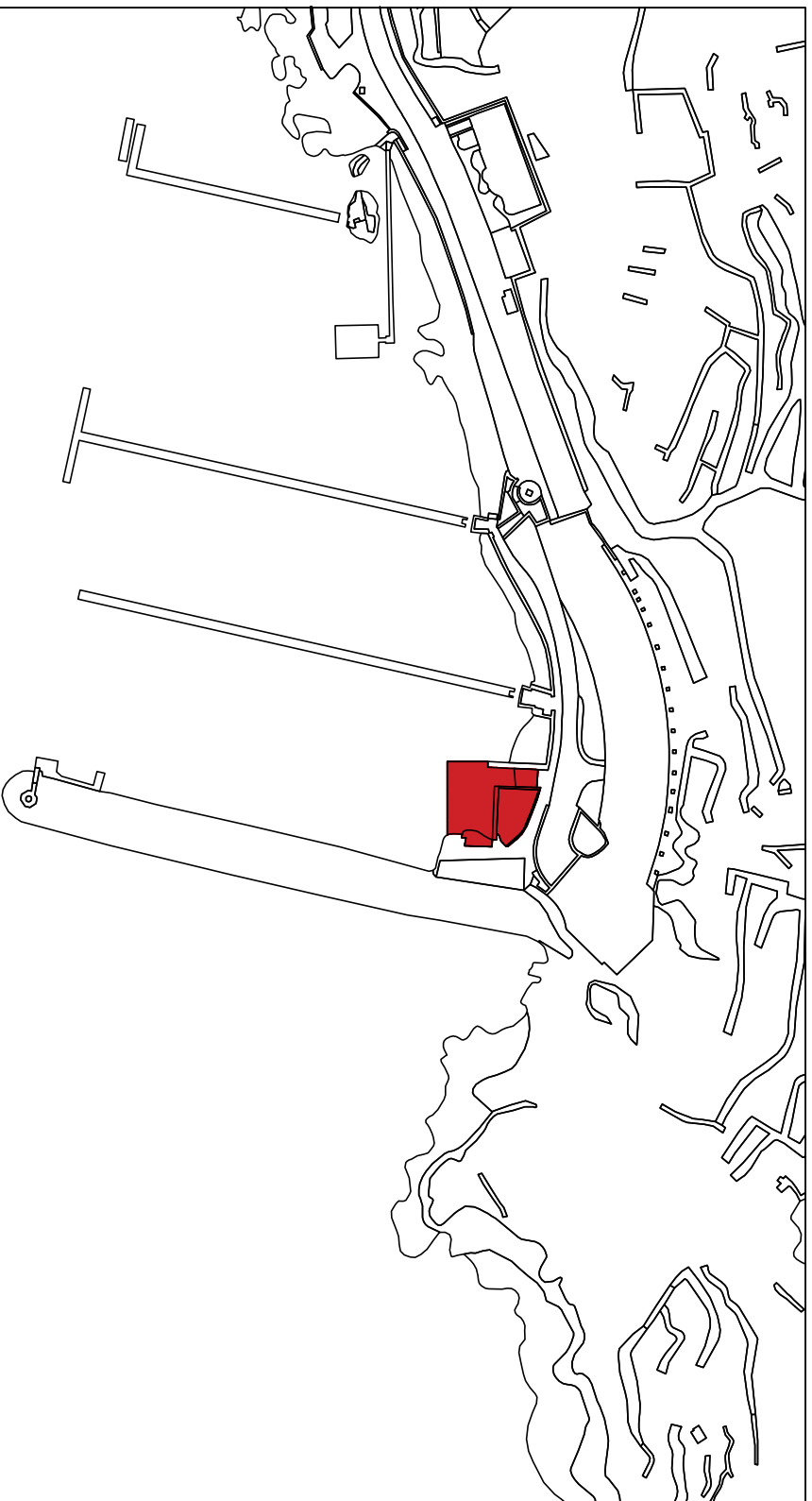


Il-Flieġu ta' Għawdex

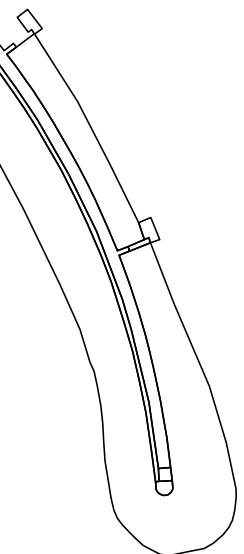
