### Further to Local Notice to Mariners No 182 of 2022 - Repair works by Enemalta on the Interconnector cable

The Ports and Yachting Directorate, Transport Malta, notifies mariners and operators of vessels, that the vessel "*CLV Nexans Aurora*" which will be doing the repair works will be berthed stern to at Delimara Power Station Quay on the following days.

The berthing of the vessel will take place between Friday 4<sup>th</sup> November and Saturday 5<sup>th</sup> November 2022 and between Friday 25<sup>th</sup> November and Monday 28 November 2022.

Due to the size and power of the vessel, the area A, B, C, D and the intermediate coastline, as shown on the attach chart, will have to be kept clear on the above-mentioned dates.

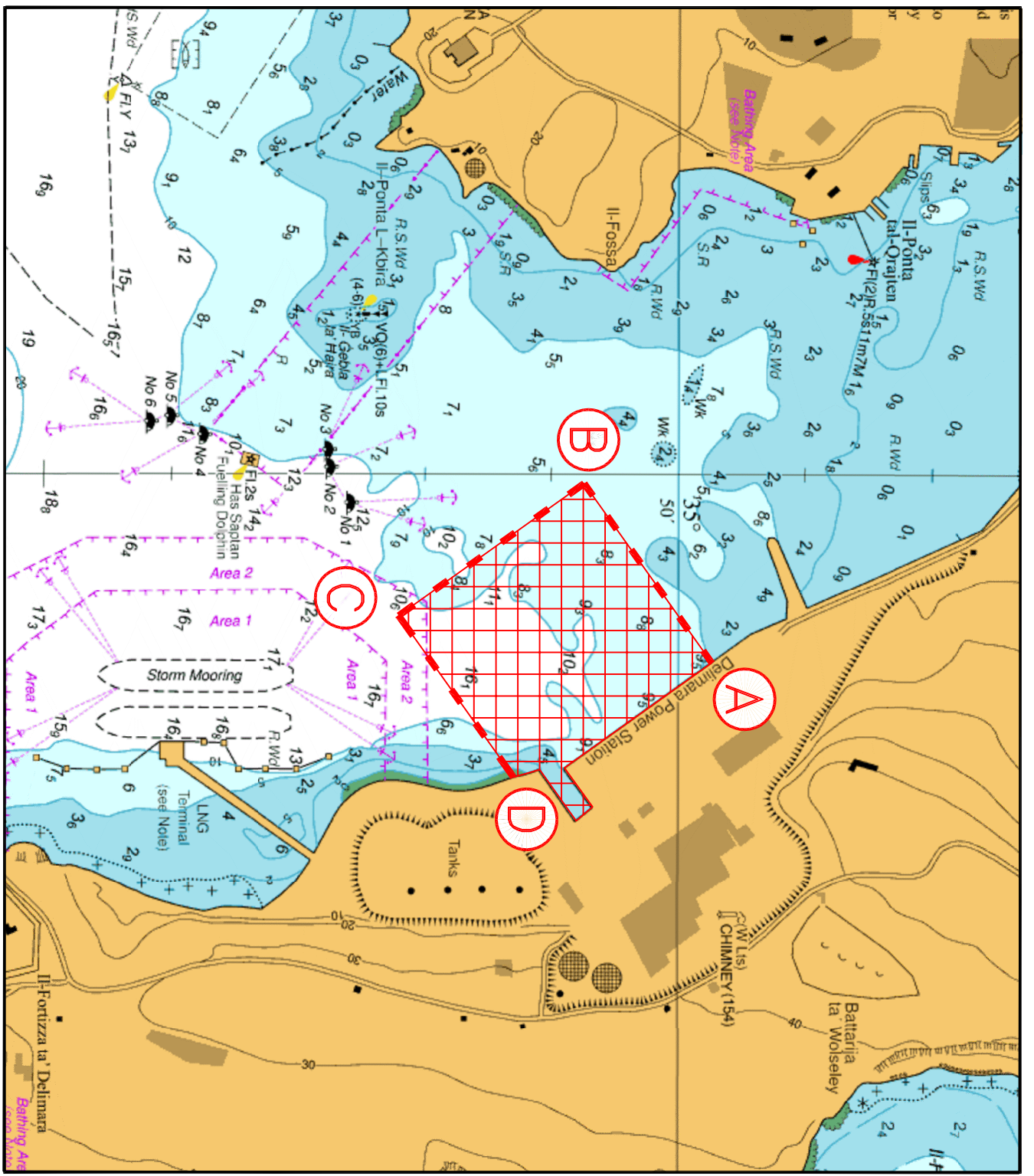
Any boats berthed or anchored within the area shown on the attached chart are to be removed during the above-mentioned dates.

Transport Malta will accept no liability whatsoever for any damage caused by the vessel while it is manoeuvring, to any vessel or other property, whether such vessel or property is left within the above-mentioned area.

Mariners are advised to navigate with caution and at slow speed. They shall keep out of the above-mentioned area and, when operating in the vicinity, they shall give the area a wide berth.

Mariners and vessel operators are to comply with instructions and directions issued on VHF Channel 14 and/or 16 by Marsaxlokk VTS.
